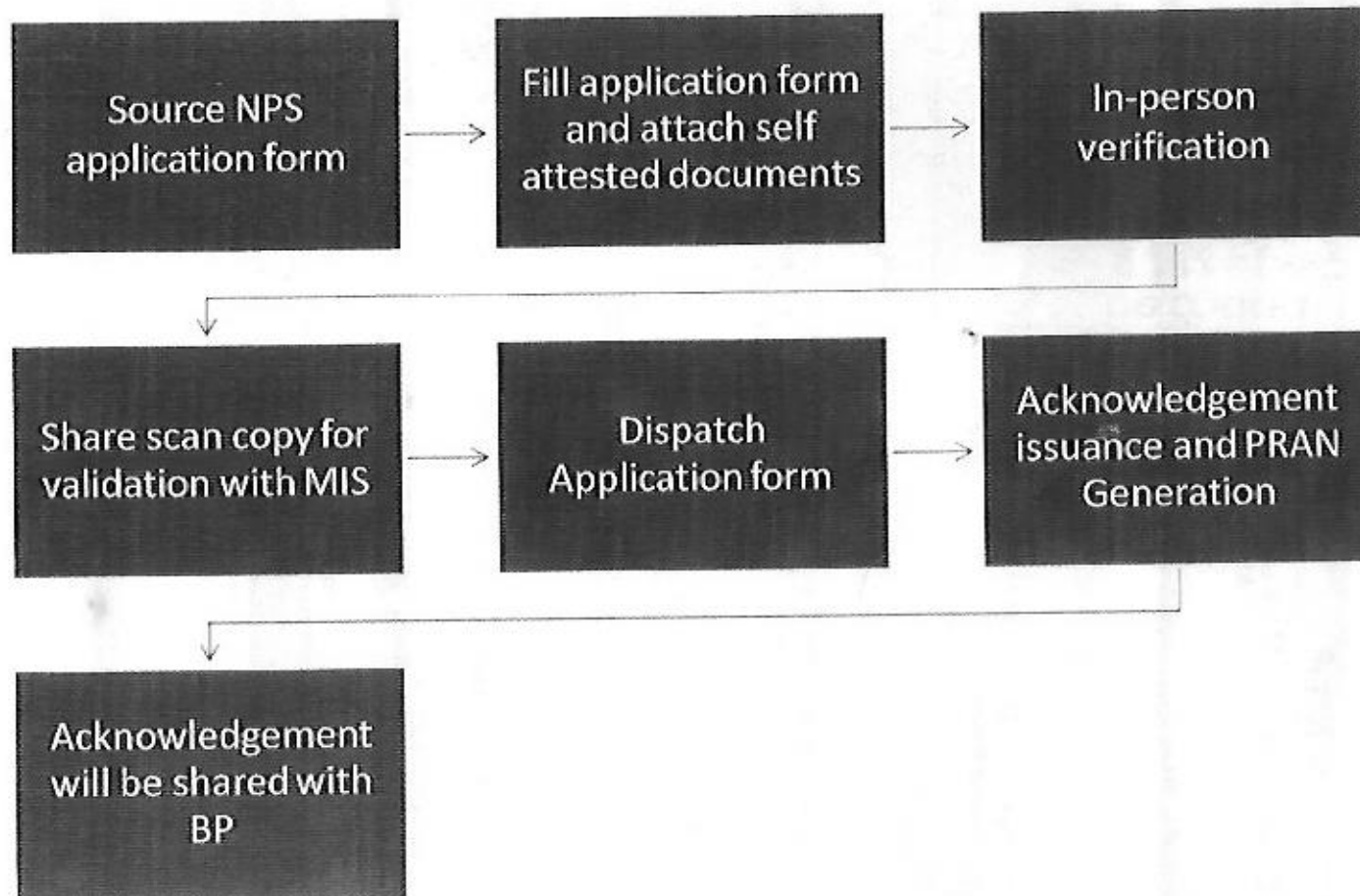


Process Flow for NPS applications



Form filling and documentation

- Please do not print application form Back to Back
- Please Fill up all the mandatory fields on Subscriber registration form
- Paste a color photograph, please don't sign over the photograph
- Sign the application in two places, please refer sample form
- Attach self-attested KYC documents
- PAN card and cancel cheque are mandatory documents
- In-person verification is must
- NPS contribution cheque should be in favor of "Religare Broking Limited, – Collection a/c NPS Trust"
- Contribution cheque should not be less than Rs 500
- Fill and attach document checklist with Application form
- Share a scan copy of form along with MIS to invest.nps@religare.com
- Dispatch the form to the given address

- Govt. employees who are mandatorily covered under NPS can contribute voluntarily for Part 1 (under the applicable settings of Part A, 1961) and for Part 2 vide the NCIS, voluntary contributions under Part 1 qualify for deduction under applicable sections of Income Tax Act, 1961 (please refer relevant provisions and rules).
- Please quote your 12 digit PAN allotted by Central Income Tax Agency (ITRA) also on the reverse of the cheque/DD. In case of new application, please mention 'New Application' on the reverse of the cheque/DD.
- Cheque/DD should be drawn in favor of 'NPS' (Name of the PSD) Collection Account - NPS Trust and crossed/ATN payable only. Please ensure sufficient balance is available in the bank account, before submitting the Cheque.
- Copy of PAN should be enclosed in case of cash contribution of Rs. 50,000 and above.
- Each contribution (in part 1 and part 2) will be treated as a separate transaction and will be charged separately. For details of the charge structure, please refer to the PRCA offer document at www.nps.gov.in.
